

This Ord Filed at Court House

ORDINANCE NO. A-340

WHEREAS, A petition was duly filed with the City Council of the City of Conway, Arkansas, on the 23rd day of March, 1959, asking the City Council of said city to vacate and abandon that part of Davis Street running North and South through Cureton Addition to Conway, Arkansas, as shown on plat of said Addition, which Street is bounded on the East by Lots One (1) to Eleven (11), inclusive, of said Addition, and on the West by Lots Twelve (12) to Twenty-two (22), inclusive, of said Addition; and,

WHEREAS, Attached to said petition is a certified copy of that portion of the plat in the office of the Recorder of Faulkner County, Arkansas, showing that portion of Davis Street running North and South through Cureton Addition to Conway, Arkansas, together with the lot numbers of each lot which abuts on the said Street hereinafter described more particularly; and,

WHEREAS, After due notice, as required by law, the City Council has, at the time and place mentioned in said notice, heard all persons desiring to be heard on the question, and has ascertained that said portion of Davis Street hereinafter more particularly described was dedicated to the public for public use, but has never been opened or used by the public as a street since said Cureton Addition was platted in 1905; that all of the owners of property abutting upon said portion of said street sought to be vacated and abandoned have filed with the City Council their written consent to such vacation and abandonment, and that the public interest and welfare will not be adversely affected by the vacation and abandonment of that portion of said Davis Street asked to be vacated and abandoned.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. The City of Conway, Arkansas, hereby releases, vacates and abandons all its rights, together with the rights of

the public generally, in and to that portion of Davis Street more particularly described as follows:

All that part of Davis Street running North and South through Cureton Addition to Conway, Arkansas, as shown on plat of said addition, which street is bounded on the East by Lots One (1) to Eleven (11), inclusive, of said Addition, and on the West by Lots Twelve (12) to Twenty-two (22), inclusive, of said addition.

All of said property being shown on a Map of said City of Conway, Arkansas, made by B. G. Wilson in the year 1917 and adopted by the City Council of the City of Conway, Arkansas, as the official map of said city on June 26th, 1917, and now duly recorded in the office of the Recorder of Faulkner County, Arkansas, in Plat Record Book "A", at pages 46, et seq.

SECTION 2. A copy of this ordinance, duly certified by the City Clerk, shall be filed in the office of the Recorder of Deeds of Faulkner County, Arkansas, for record.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication.
