

ORDINANCE NO. A-461

AN ORDINANCE VACATING A CERTAIN ALLEY IN  
BLOCK 14, SRYGLEY ADDITION TO THE CITY OF  
CONWAY, ARKANSAS.

Whereas, a petition was duly filed with the City Council of the City of Conway, Arkansas, on the 22nd day of April, 1968 asking the City Council to vacate and abandon all, that portion of the alley designated on the plat of the Srygley Addition to said city, now appearing of record in Plat Book "A", Pages 46 et seq., in the Office of the Recorder of Faulkner County, Arkansas; and

Whereas, after due notices as required by law, the Council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the alley or the portion thereof, hereinbefore described, has heretofore been dedicated to the public as an alley herein described; has not been actually used by the public generally for a period of at least five years subsequent to the filing of the plat; that all the owners of the property abutting upon the portion of the alley to be vacated have filed with the Council their written consent to such abandonment; and that public interest and welfare will not be adversely affected by the abandonment of such alley.

Now, therefore, be it ordained by the City Council of the City of Conway, Arkansas:

Section 1. The City of Conway, Arkansas hereby releases, vacates and abandons all its rights, together with the rights of the public generally in and to the alley designated as follows:

Begin at the southeast corner of Lot 1 and run thence west 264 feet to the southwest corner of Lot 5; thence south 14 feet to the northwest corner of Lot 6; thence east 264 feet to the northeast corner of Lot 10; thence north 14 feet to the point of beginning, all in Block 14, Srygley Addition to the City of Conway, Arkansas.

Section 2. A copy of the ordinance duly certified by the City Clerk shall be filed in the office of the recorder of the county and recorded in the deed records of the county.

Section 3. This ordinance shall take effect and be in force from and after its passage.
