

ORDINANCE NO. O-76-1

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN
TERRITORY TO THE CITY OF CONWAY, ARKANSAS;
DECLARING SUCH TERRITORY TO BE A PART OF SAID TOWN;
DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, Charles M. Stout and C. Michael Stout, who have filed petitions in the County Court of Faulkner County, Arkansas, for the annexation into the City of Conway, Arkansas, of the hereinafter described lands, are more than fifty percent of the owners in number and own more than fifty percent in acreage of said lands; and

WHEREAS, by Resolution No. R-75-20, dated the 11th day of November, 1975, the City Council of the City of Conway, Arkansas, declared its willingness to accept the hereinafter described lands as a part of the City of Conway, Arkansas; and

WHEREAS, after proceedings being had upon notice by publication, all as provided by and in accordance with the laws of the State of Arkansas, the Judge of the County Court of Faulkner County, Arkansas, did, on December 17, 1975, enter his order of annexation to said City of the hereinafter described lands.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the City Council of Conway, Arkansas, does hereby accept the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on December 17, 1975, said territory being described as follows, to-wit:

The S 1/2 SW 1/4 SW 1/4 of Section 36, Township 6 North, Range 14 West, containing 19.88 acres, more or less.

And that said above-described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: It is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.
