

AN ORDINANCE AMENDING SECTION ~~4~~.24 OF THE
CONWAY MUNICIPAL CODE, DECLARING AN EMERGENCY
AND FOR OTHER PURPOSES

WHEREAS, the City Council has determined that Section 4.24 of the Conway Municipal Code needs to be amended in order to up date the regulations and requirements contained therein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That Section 4.24.02 Application is hereby amended as follows:

Every hawker, peddler, person, firm, or corporation before engaging in business for the purpose stated in Section 4.36.01, shall make an application for a permit to engage in such business and shall present such application to the clerk/treasurer for his approval. Said application shall give the following information; name, address, nature of business, method of distribution used, description of produce or merchandise to be sold, and period for which applicant desire to hawk or peddle within the city. The permit shall be issued by the City Clerk/Treasurer except on week ends and holidays in whcih event, the application is to be made to the officer in charge at the Conway Police Department.

Section 2: That Section 4.24.04 Amount of License is hereby amended as follows:

The license fee for such permit as set forth is to be ONE HUNDRED DOLLARS AND NO/100 (\$100.00) per year or FIVE DOLLARS AND NO/100 (\$5.00) per day and is to be paid to the City Clerk/Treasurer prior to the issuance of the permit.

The fee for the permit shall not apply to Faulkner County residents, who sell, peddle, or hawk fruit or vegetables that they have grown themselves.

All portions of Section 4.24.04 are hereby specifically repealed.

Section 3: Section 4.24.08, Obstructing Traffic will be added to Section 4.24 of the Conway Municipal Code as Follows:

It shall be unlawful for any person obtaining a permit pursuant to this ordinance, to conduct such sale or engage in such business arising under this section in a place, or in a manner which blocks or obstructs vehicular traffic or in any way creates a hazardous driving condition. The Chief


of Police or his officers shall have authority to revoke the permit issued pursuant to this section of any person, firm or corporation who conducts a sale in a manner which blocks and/or obstructs or creates a hazardous driving condition. The revocation of such permit shall not preclude any other penalties provided in this ordinance.

Section 4: All portions of the amended sub-sections of Chapter 4.24 of the Conway Municipal Code in conflict with this ordinance are hereby specifically repealed. Further, in the event any portions of said amended 4.24 of the Conway Municipal Code are declared invalid or unconstitutional for any reason, the remaining portions are to remain in full force and effect.


