

ORDINANCE NO. 0-79-16

WHEREAS, the following persons, Claude H. Hazel, Jr., Thomas Hazel, Greta Mitchell, Betty Hightower, Wilodene Palmer, Don Keathley and Lynn Keathley, owners of the hereinafter described lands, did petition the County Court of Faulkner County, Arkansas, for an Order annexing said lands and territory to the City of Conway, Arkansas; and

WHEREAS, after proceeding being had upon Notice by publication, all as provided by law and in accordance with the laws of the State of Arkansas, the Judge of the said County Court did, on the 6 day of March, 1979, enter his order of annexation to said City of the hereinafter described lands:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That the City Council of Conway, Arkansas, does hereby accept the hereinafter described lands and territory, annexed to said City by Order of the County Court of Faulkner County, Arkansas, heretofore entered on the 6th day of March, 1979, said territory being described as follows, to-wit:

Being a part of the E $\frac{1}{2}$ , NW $\frac{1}{4}$ , Section 9, T5N, R13W, Faulkner County, Arkansas, described as beginning at the Ne corner of said E $\frac{1}{2}$ , NW $\frac{1}{4}$ ; thence along East line of said E $\frac{1}{2}$ , S-1-12-18-E 1,891.90 feet to the point of beginning; thence continuing, S-1-12-18-E 765.92 feet to the SE corner of said E $\frac{1}{2}$ ; thence along South line of said E $\frac{1}{2}$ , S-89-34-18-W 1,320.73 feet to the SW corner of said E $\frac{1}{2}$ ; thence along West line of said E $\frac{1}{2}$  N-0-51-44-W 2,458.19 feet; thence East 210.0 feet; thence N-0-51-44-W 210.0 feet to the North line of said E $\frac{1}{2}$ ; thence along said North line East 626.96 feet to a point 468.0 feet West of the NE corner of said E $\frac{1}{2}$ ; thence S-0-01-18-E 210.0 feet; thence N-89-56-22-E 19.0 feet; thence S-1-12-48-E 228.53 feet; thence S-89-46-50-W 258.63 feet; thence S-1-39-46-E 501.37 feet; thence S-88-34-27-W 165.60 feet; thence S-1-46-33-E 293.0 feet; thence N-88-31-20-E 165.60 feet; thence S-1-41-39-E 51.74 feet; thence S-88-20-53-W 25.67 feet; thence S-1-33-50-E 168.75 feet; thence S-87-44-19-W 107.96 feet; thence S-0-1-8-55-W 325.40 feet; thence N-88-18-23-E 152.94 feet; thence S-3-06-24-E 46.49 feet; thence N-87-58-02-E 261.07 feet; thence S-3-21-29-E 82.20 feet; thence N-89-08-21-E 424.06 feet to the point of beginning containing 49.23 acres, more or less. Reserving all roadways, public or private which might be hereon.

and that said lands and territory be, and the same hereby are declared to be a part of the City of Conway, Faulkner County, Arkansas.

2. That it is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; that this ordinance shall take effect and be in force from and after its passage and publication.
