

ORDINANCE NO. 0-96- 47

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1 : The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to the City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 10 day of April, 1996, and said territory being situated in Faulkner County, Arkansas, shall be a part of the City of Conway and shall be zoned A-1 and described as follows:

Being a Part of the **NE1/4 NE1/4**, section 5, T-5-N, R-13-W, Faulkner County, Arkansas, described as commencing at the SE corner of said **NE 14 NE1/4** and run N 1 degree 06' 00" W along the East line of said **NE1/4 NE1/4** 467.4' to the point of beginning: thence continue N 1 degree 06' 00 W, 833.42' to the NE Corner of said **NE1/4 NE1/4**; thence S 89 degrees 38' 42" W, 1326.32' to the NW Corner of said **NE1/4 NE1/4**: thence S 1 degree 13' 52" E, 1286.82 to the SW Comer of said **NE1/4 NE1/4**: thence S 89 degrees 44' 50" E along the South line of said **NE1/4 NE1/4**, 71.42'; thence N 1 degree 06' 00" W, 467.4; thence s 89 degrees 44' 50" E, 1252.2' to the point of beginning. Containing 25.91 Acres, more or less. This tract is not located in a Special Flood Hazard Area.


and that said above-described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2 : From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of the said City of Conway, Arkansas, and for yoting purposes, said lands are hereby assigned to and designated as a part of Ward 2 of the City of Conway, Arkansas.

SECTION 3 : It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted ; that an emergency exists ; and that this ordinance shall take effect and be in force from and after its passage and publication.
