ORDINANCE NO. 0-2-09

AN ORDINANCE ADOPTING A BUDGET FOR THE STREET DEPARTMENT OF THE CITY OF CONWAY, ARKANSAS, FOR THE FISCAL YEAR JANUARY 1, 2002 THROUGH DECEMBER 31, 2002, AND PROVIDING THAT THE SEVERAL AMOUNTS STATED IN THE BUDGET DOCUMENT AS ADOPTED EXPENDITURES SHALL BECOME APPROPRIATED FOR THE VARIOUS FUNCTIONS AND ACTIVITIES SPECIFIED IN SAID BUDGET DOCUMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Mayor of the City of Conway has submitted to the City Council A STREET DEPARTMENT BUDGET FOR THE FISCAL YEAR 2002;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. A budget for the fiscal year 2002 for the Street Department of the City of Conway, Arkansas, as set forth in the document entitled "Conway Street Department Estimated Project Cost and Fund Balance"; providing a total appropriation for all Engineering and Street Department projects of \$1,882,000.00.

SECTION 2. That from the effective date of the budget, to wit: January 1, 2002, the several amounts as stated therein as adopted expenditures shall be and are hereby appropriated for the several purposes, functions, and activities within the various departments, offices, and agencies specified therein.

SECTION 3. The Mayor is directed to cause the proper accounting entries to be made in the books and records of the City so as to reflect the appropriations for the aforesaid fiscal year, and he is further directed to file a certified copy of the adopted budget for the fiscal year with the City Clerk of the City of Conway, Arkansas.

SECTION 4. That all ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 5. That this ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.


