AN ORDINANCE APPROPRIATING STREET DEPARTMENT FUNDS; DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, the Conway City Council on April 1, 2003, approved the following street projects for 2003:

- Amtran Off Ramp (with \$200,000 ADED Grant) \$250,000.00
- Exchange Connection at Ninth Avenue 35,000.00
- Tyler Street Overlay - Brierwood to Washington 55,000.00
- Sixth Street Rehab & Overlay - Ffth Avenue to Tilk 45,000.00
- Seibenmorgen Rd - Freyaldenhoven to Green House - open ditch 90,000.00
- College-Salem Intersection - Added West Bound Rt. Turn Lane 35,000.00
- Southern Hills Phase 2 Overlay 21,000.00

; and

WHEREAS, the 2003 Street Department Budget lacks \$84,430.00 containing enough funding for the approved projects;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1. The city of Conway shall appropriate \$84,430.00 from the Street Department Reserve to the Street Department Projects Account.

SECTION 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 3. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.


