**ORDINANCE NO. O-05-169**

**AN ORDINANCE APPROPRIATING FUNDS FOR THE PURCHASE OF RESIDUAL PROPERTY IN THE AREA BETWEEN WINDSOR PARK SUBDIVISION AND SALEM ROAD (LOT 65 WINDSOR PARK); DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:**

**WHEREAS**, the Mayor and the Conway City Council approved at the September 27, 2005 meeting to purchase 0.844 acres from Rush Hal Development, LLC (area that is not required for right of way for the Salem Road Railroad Overpass) and the AHTD will purchase 0.76 acres.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:**

**SECTION 1.** The City of Conway shall appropriate \$22,642 from the Fund Balance Appropriation Account to the Land Account (01.106.911).

**SECTION 2.** All ordinances in conflict herewith are repealed to the extent of the conflict.

**SECTION 3.** This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.


