**ORDINANCE NO. O-05-172**

**AN ORDINANCE APPROPRIATING FUNDS FOR ANIMAL WELFARE VEHICLE PURCHASE; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:**

WHEREAS, the City Council of the City of Conway approved the purchase of a vehicle for the Animal Welfare Unit on November 22, 2005, and

WHEREAS, the AWU has undesignated contingency funding available in the amount of \$7,000, and

WHEREAS, the vehicle purchase for AWU is anticipated to cost \$14,000, necessitating an appropriation of \$7,000 from the General Fund;

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:**

**SECTION 1.** The City of Conway shall appropriate funds for the Animal Shelter through a General Fund Balance appropriation in the amount of \$7,000, which shall be transferred to the Special Revenue Fund – Ad Valorem Animal Welfare Vehicle Account and shall designate \$7,000 in the Special Revenue Fund Undesignated Contingency Account (20.126.999) to the Vehicle Account.

**SECTION 2.** All ordinances in conflict herewith are repealed to the extent of the conflict.






