ORDINANCE NO. O-06-13

**AN ORDINANCE APPROPRIATING FUNDS TO REPAIR TWO LEACHATE PUMPS,
DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES,**

WHEREAS, the City of Conway Sanitation Department has a need for \$5,876 to repair two Leachate Pumps and \$2,000 for the Installation of these pumps; and

WHEREAS, the City of Conway Sanitation Department will use funds from the Enterprise Budget (50.118.999, Undesignated Contingency) transferred into the Sanitation Improvements Account (50.118.915).

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. The City of Conway Sanitation Department will use H & E Incorporated to purchase the Leachate Pumps because they have been found to have provided the lowest quote.

The City of Conway Sanitation Department will use Hambuchen Electric to install the pumps because they have been found to have provided the lowest quote.

SECTION 2. All ordinances in conflict herewith are repealed to the extent to the conflict.




