

RESOLUTION R-78-59

WHEREAS, more than one-half ($\frac{1}{2}$) of the owners by number and by area, of the following described lands in Faulkner County, Arkansas have petitioned the County Court of Faulkner County, Arkansas for an Order annexing said lands in the City of Conway and,

WHEREAS, it is the desire of the City Council to indicate the County Court of Faulkner County, Arkansas that the attitude of the City of Conway towards to such annexation and,

WHEREAS, there is a possibility of a delay in providing drainage and/or street improvements in the hereinafter described property for as long as possibly two (2) years, which is understood and agreed to, and,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONNWAY, ARKANSAS, that its willingness to accept the following described property into the City of Conway, Arkansas be and the same is hereby made known with the understanding, that there could possibly be a delay for as long as two (2) years in providing drainage and/or street improvements within said area and that demand will not be made upon the City to do such improvements for a period of two (2) years, and the City does hereby express its willingness under said conditions to accept as part of the City the following described property to-wit:



The North Half of the Southeast Quarter ($N\frac{1}{2} SE\frac{1}{4}$), Section 35, Township 6 North, Range 14 West; the Northwest Quarter Southwest Quarter ($NW\frac{1}{4} SW\frac{1}{4}$), Section 36, Township 6 North, Range 14 West; and the North Half Southwest Quarter Southwest Quarter ($N\frac{1}{2} SW\frac{1}{4} SW\frac{1}{4}$), Section 36, Township 6 North, Range 14 West, containing in the aggregate 140 acres, more or less.

Also Part of the Southeast Quarter ($SE\frac{1}{4}$) of the Northeast Quarter ($NE\frac{1}{4}$) Section 35, T6N, R14W, Faulkner Co., Arkansas described as follows: Beginning at a point 267 ft. West of the Southeast Corner of said Southeast Quarter ($SE\frac{1}{4}$) of the Northeast Quarter ($NE\frac{1}{4}$), Sec. 35; thence West 863 ft.; thence North 878 ft. to the South right of way of State Highway 64 west; thence running East along said South right of way of Highway 64 West 863 ft.; thence running south to the point of beginning, containing 17 acres, more or less.
