Tucker, to close that portion of an alley lying on the East side of Lot 22 of Block 1 of Anderson's Addition to City of Conway, Arkansas, and the West side of Lots 1, 2, and 3 of Block 1, of Anderson' Addition to the City of Conway, Arkansas, said alley being 10 feet wide, be held at 6:30 p.m. on the 23rd day of February, 1982.

IT IS FURTHER RESOLVED that proper notice be run in the Log Cabin Democrat, all as required by Ordinance.

1. That these petitioners are the owners of the following  
described proerty, to-wit:

Arkansas; AND the West 48 feet of Lots 1 and 2, and the  
West 48 feet of the North 1/2 of Lot 3, in the Anderson's  
Addition to the City of Conway, Arkansas.

2. That lying on the East side of Lot 22, and the West side  
of Lots 1, 2, and 3, is an alley way 10 feet wide, which is not  
now being used, nor has it ever been used by the public generally  
or any one specifically for any purpose whatsoever.

3. That there are no easements or utility in and around,  
under, through or across said alley.

4. That said alley is not serving the public generally or  
specifically and it would be in the best interest of the pro-  
perty owners, these petitioners, to abandon and close said alley.


WHEREFORE, these Petitioners, by and through their attorney,
