

A RESOLUTION OF INTENT TO ANNEX PROPERTY TO THE CITY OF CONWAY, ARKANSAS

WHEREAS, The owners of the below described property have petitioned the city to annex said lands to the city of Conway, and to zone the property R-1 and A-1 as indicated;

Part of the N $\frac{1}{2}$ SW $\frac{1}{4}$, Section 9, Township 5N, Range 13W Faulkner County, Arkansas. Described as beginning at the SW corner of said N $\frac{1}{2}$ of SW $\frac{1}{4}$, thence run North along the West line of said N $\frac{1}{2}$, SW $\frac{1}{4}$, 1,325.4 feet to the NW corner of said N $\frac{1}{2}$ SW $\frac{1}{4}$; thence east along the north line of N $\frac{1}{2}$ of SW $\frac{1}{4}$ 1,850.7 feet thence southeastwardly to a point on the south line of said N $\frac{1}{2}$, SW $\frac{1}{4}$ said point being 1,932 feet east of the SW corner of said N $\frac{1}{2}$ SW $\frac{1}{4}$; thence west, 1,932 feet to the point of beginning. Less and except that part which is already taken into the city limits. Containing 44.2 acres more or less.

All of which is to be zoned R-1, except part of the east end which is described as beginning at a point 1,283.7 feet east of the NW corner of said N $\frac{1}{2}$ SW $\frac{1}{4}$, thence run east 567 feet, thence southeastwardly to a point on the south line of said N $\frac{1}{2}$ SW $\frac{1}{4}$, said point being 1,932 feet east of the SW corner of said N $\frac{1}{2}$ SW $\frac{1}{4}$; thence west, 670.4 feet to the east line of existing city limits thence northward along existing east line, 515 feet; thence northward to the point of beginning, containing 18.7 acres to be zoned A-1.


WHEREAS, The city planning commission has considered this annexation petition and recommended to the city council that the property be annexed to the city and zoned R-1 and A-1 as indicated; and

WHEREAS, The property is contiguous to the city limits on three sides and city utilities are readily available;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:


1. It is the intent of the city council of the city of Conway, Arkansas to pass an ordinance annexing and zoning these lands upon the proper action and release of the property by the County Court.
