

RESOLUTION NO. R-85-25

WHEREAS, the following named persons, to-wit: The Conway Corp., T. J. Nahlen Phil Moix, and Chester Moix, being a majority of the owners of real estate and owning more than one-half of the acreage described in exhibit "A" hereto have petitioned and/or will petition the County Court of Faulkner County, Arkansas for abandonment from said County for the purpose of annexation into the City of Conway, Arkansas; and,

WHEREAS, it is desirable to indicate unto the County Court of Faulkner County, Arkansas the willingness of the City of Conway, Arkansas concerning said annexation.
