

RESOLUTION

BE IT RESOLVED, by the City Council of the City of Conway, Arkansas, that WHEREAS, the City Council of the City of Conway, Arkansas, has been informed that John W. Hart, Anna Mae Hart, and Meg Lynn "Toby" Hart have petitioned or will petition the County Court of Faulkner County, Arkansas, for annexation into the City of Conway, Arkansas, of the following described lands in Faulkner County, Arkansas:

Part of the NE 1/4 of Section 9, Township 5 North, Range 13 West, described as beginning at a point which is 210 feet south of the northwest corner of said NE 1/4 and run thence south along the west line of said NE 1/4 to the southwest corner of said NE 1/4; thence east along the south line of said NE 1/4 to the southeast corner of the West 1/2 NE 1/4 of said Section 9; thence north 0 degree 06 minutes 50 seconds west along the east line of said West 1/2 NE 1/4, a distance of 1180.73 feet; thence south 89 degrees 22 minutes 38 seconds east 474.0 feet; thence north 50 degrees 35 minutes 01 seconds east 503.62 feet; thence north 00 degree 17 minutes 05 seconds west 375 feet; thence north 89 degrees 22 minutes 38 seconds west 635.12 feet; thence south 00 degree 10 minutes 24 seconds east 399 feet; thence north 89 degrees 22 minutes 38 seconds west 226 feet to the east line of the West 1/2 NE 1/4; thence north 00 degree 06 minutes 50 seconds west 1180.16 feet, to the northeast corner of the said West 1/2 NE 1/4 of said Section 9; thence west along the north line of the West 1/2 NE 1/4 to a point which is 810 feet east of the northwest corner of said NE 1/4; thence south 210 feet; thence west 177 feet; thence north 210 feet to the north line of said West 1/2 NE 1/4; thence west along said north line to a point which is 210 feet east of the northwest corner of said NE 1/4; thence south 210 feet; thence west 210 feet, to the point of beginning, containing 90.38 acres, more or less.

WHEREAS, it is desired to indicate unto the County Court of Faulkner County, Arkansas, the attitude of the City of Conway, Arkansas, toward such annexation.

NOW, BE IT RESOLVED by the City Council of the City of Conway, Arkansas, that said City Council does hereby declare its willingness to accept said lands as a part of the City of Conway, Arkansas, provided said County Court of Faulkner County, Arkansas, shall, in the exercise of its discretion, deem said lands suitable for annexing unto the City of Conway, Arkansas.
