



City of Conway -- City Council Brief
August 22, 2006

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-06-106} changing the name of the portion of Siebenmorgen Road that runs north-south from the intersection of the new Siebenmorgen (future) to the intersection of Trison Lane and Bill Lucy Drive to Trison Lane. **Vote 8-0**
- Ordinance {O-06-107} appropriating funds in the amount of \$9,665 to the Conway Permits Department for additional funding for the Code Enforcement officers operating expenses. **Vote 8-0**
- Ordinance {O-06-108} declaring an extension of the moratorium established by O-06-37 on the issuance of residential building permits in Old Conway until October 30th, 2006. **Vote 7-1 w/ Alderman Brewer voting against.**
- Ordinance {O-06-109} appropriating donation funds from First State Bank (\$1,000) & Sonic Drive in (\$1,000) for a total amount of \$2,000 for sponsorship for Lights over the Lake. **Vote 8-0**
- Ordinance {O-06-110} appropriating funds in the amount of \$8,000 to replenish the gasoline & diesel account for Parks & Recreation. **Vote 8-0**
- Ordinance {O-06-111} appropriating funds in the amount of \$10,000 to replenish the building maintenance account for the remainder of the year for P&R. **Vote 8-0**
- Ordinance {O-06-112} appropriating asset forfeiture funds in the amount of \$4,507 to the CPD to replace items on two patrol motorcycles. **Vote 8-0**
- Ordinance {O-06-113} accepting donation of a customized swat bus from IC Corporation & others to the CPD. **Vote 8-0**
- Ordinance {O-06-114} accepting assets obtained through a court order with a stated value of \$2,850 to the CPD. **Vote 8-0**

Ordinances Failed: None

Resolutions Passed

- Resolution {R-06-30} setting a public hearing to vacate a street/alley on a portion of Museum Road. **Vote 8-0.**

In other actions, the Council:

- Approved a request from the Bank of Dardanelle for a parking lot variance for property located at 4055 College Avenue. ***Vote 8-0***
- Approved a request from Ken-Mark Construction to remove the structures at YBMA fairgrounds in the amount of \$9,875.00. ***Vote 8-0***
- Approved a request by Conway Public School District for an additional police officer to be used as an SRO officer. ***Vote 8-0***
- Approved the request for proposal from Cross, Gunter, Witherspoon, & Galchus for Legal Representation of Management in Civil Service Commission Appeal Hearings. ***Vote 8-0***

Held in Committee

- ◆ Consideration of an ordinance creating an old Conway Design Overlay District.
- ◆ Consideration of a request to construct sidewalks at the Fairgrounds and Favre Lane in lieu of required subdivision construction.
