City of Conway -- City Council Brief
December 28th, 2006

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-06-172} appropriating funds in the amount of \$32,000 for Timberpeg Subdivision & Front Street improvements. **Vote 8-0**
- Ordinance {O-06-173} accepting seized vehicle awarded to the City through court order. (Only three of the six were accepted for an estimated value of \$7,400). **Vote 7-1 w/ Alderman Grimes voting against**
- Ordinance {O-06-174} adopting the budget for FY 2007. **Vote 8-0**

Ordinances Failed:

- ♦ Ordinance {O-06-170} to rezone property located at Conway Towne Centre off Skyline Drive from PUD (C-4) to C-3. (**Vote 4-4**)
- ♦ Ordinance {O-06-171} to rezone property located at Conway Towne Center from PUD (C-4) to C-3. (**Vote 2-6**)

Other actions:

In other actions, the Council:

- ♦ Approved nominations for the following City boards: Oak Grove Cemetery, Advertising & Promotion, Tree Board USA, Board of Zoning Adjustment, CDBG Advisory Board, Historic District Commission, Public Art Project Committee, & Old Conway Design Review Board. **Vote 8-0**
- ♦ Approved forgiving debts from different vendor, prior to 2003 at the Conway Sanitation Dept. **Vote 8-0.**

- ♦ Approved to the purchase of (2) additional residential trucks from Barloworld from a previous bid (2006-33). ***Vote 8-0***
- ♦ Approved to jointly pursue civil & criminal charges for unauthorized charges that were made on an account at the Conway Sanitation Department. ***Vote 8-0***
- ♦ Approved to remove property from the fixed assets inventory list. ***Vote 8-0***
- ♦ Approved to add two journeyman & license master pay to the Sanitation Department pay scale. ***Vote 8-0***
- ♦ Approved moving the January 9th, City Council meeting to January 8th due to the Governor inauguration. ***Vote 8-0***
