On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderwoman Mehl, Alderwoman Smith, Alderman Vaught, Alderman Rhodes, & Alderman Jones. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett & City Attorney Michael Murphy. Alderwoman Mary Smith was not present.

Ordinance Passed:

- O-11-25 Ordinance to change the name of Southwestern Energy Drive to SWN Drive. **Vote 7-0 w/ Alderwoman Smith not present.**
- O-11-26 Ordinance closing the easternmost 794 feet of Bruce Street (Oak Grove Cemetery Entrance on East) on the southern edge of Cantrell Airfield. **Vote 7-0**
- O-11-27 Ordinance amending Ordinances O-06-139 (Old Conway Design Overlay District) and O-10-12 Historic District Commission, which would combine these boards. **Vote 7-0**

In Other Actions:

Approved the nomination of Steve Connors for the Conway Corporation Board of Directors. **Vote 7-0**

Approved the recommendation for tree trimming to remove obstructions at Cantrell Field (west end of Runway). **Vote 6-1 w/ Alderman Vaught voting against.**

Approved to accept the low bid from A.G. Hunt Construction Inc. in the amount of \$1,592,606.20 for the Stage 1A-Grading and Construction for the new Conway Municipal Airport. **Vote 7-0**

Approved to amend the contract with Garver & Garver for the new Conway Municipal Airport. **Vote 7-0**

Approved a conditional use permit from Deep Well Campus Ministries to allow restricted office and religious activities in an R-2A zone for the property located at 625 Donaghey Avenue (Southwest corner of Donaghey and Louvenia). **Vote 7-0**

Approved to accept the bid from Tri-State Truck Center in the amount of \$230,470 for a 2012 Automated Side Loading Refuse Truck for the Conway Sanitation Department. This bid had previously been awarded (03-08-11) to Shipley Motors however they were unable to meet bid specifications in regards to a delivery date; therefore went with the second bidder. **Vote 7-0**

Approved a change order by Salter Construction in the amount of \$19,350 for various items needed for completion of Conway Station Park. **Vote 7-0**

Approved the low bid from Luber Bros in the amount of \$21, 161.14 for two Infielder Rakes (2011 Smithco Super Star G Model 9440) for the Conway Parks & Recreation Department. **Vote 7-0**

Consideration of a property exchange between the Hart Family & the City of Conway.

Resolution creating a City of Conway Reserve Account.
