### **Ordinance Passed:**

- O-11-57 Ordinance appropriating funds for transportation services for the Boys & Girls Club of Faulkner County & FCCDD. **Vote 6-2 w/ Alderman Vaught & Hawkins voting against.**
- O-11-58 Ordinance amending the sign ordinance in regards to pre-existing non-conforming signs. **Vote 5-3 w/ Alderman Jones, Whitmore, & Vaught voting against.**
- O-11-59 Ordinance authorizing a credit card transaction fee collected by District Court. **Vote 8-0**

### **Resolution Passed:**

- R-11-35 Resolution naming the Conway Optimist Youth Football Field at Curtis Walker Park "Peyton Hillis Field". **Vote 8-0**
- R-11-36 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **3035 Franklin Street** as a result of incurred expenses by the City. **Vote 8-0**
- R-11-37 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **2016 Sugar Creek Drive** as a result of incurred expenses by the City. **Vote 8-0**

- Approved the change order request for A.G. Hunt Construction Co for Stage 1A Airport Construction.
- Approved a request by Rick Lawson to obtain a franchise agreement for a taxi service (Cab's Here).
